Most bare root stock are tied in bundles of 10 plants; 24"-30" are tied in bundles of 5 plants. Plugs are sold in 72 cell trays.

TERMS - We require a deposit of 25% of total balance when placed to hold order, with full payment due before shipping date or March 1, 2022, whichever comes first. **Customer assumes full responsibility for meeting payment due date(s); unpaid balances may result in order cancellation.** Customers with open accounts: the terms are 2% 10 days, net 30 days. A finance charge at the rate of 1½% per month (18% annually) will be charged on any balance after 30 days.

We will consider new open accounts only after written request. We will need you to complete and sign our Credit Application for us to consider opening an account for you.

CANCELLATIONS - Cancellations before March 15th will be subject to a 25% cancellation fee.

Cancellations after March 15th will be subject to full price of plants; or 25% cancellation fee if we are able to find another buyer for your plants.

SHIPPING - We pack all of our stock with the greatest of care. All shipments travel at the purchaser's risk and expense. Purchaser must file a claim with the transportation company if the shipment is damaged in transit. Plants will be shipped via United Parcel Service (UPS) if possible. If other means of transportation is desired, please advise when placing order.

LIMITED WARRANTY - Should any stock prove untrue to name as labeled, it is mutually agreed that our total liability, upon satisfactory proof, shall be limited to replacement or refund not to exceed the original purchase price. All orders are accepted subject to crop failures, damage by natural causes, and we reserve the right to refund all or any part of payment made. **We give no warranty expressed or implied as to the growth or productivity and will not in any way be responsible for the results secured in transplanting.**

CLAIMS - We will correct any errors, but we cannot honor any claims that are not made within 10 days after receipt of the stock. Claims should be made promptly and in writing.
